

Matrix for the preparation of common modifications and or the inclusion of the Annex ZA/ZZ

The purpose of this matrix is to give an overview about the process when Common Mods/European Annexes (ZZ/ZA) are needed by the TB. The process may change depending on the reached stage during the standardization development. This matrix should show the procedures when the TB decides to introduce Common Mods/European Annexes (ZZ/ZA) for each stage/scenario.

Common Mods: Common Mods are made available as European Amendments (A1x). They will be made available as a separate document
